## ENDORSEMENT APPLICATION- MARIJUANA PRODUCT MANUFACTURING FACILITY

Application for endorsement subject to 11 AAC 40.400 – 11 AAC 40.420. **Before being offered with or without compensation to a consumer in the state, any industrial hemp product processed beyond its raw form and intended for human or animal consumption must be endorsed by the division.**

**Applies to marijuana product manufacturing facilities licensed through the Alcohol and Marijuana Control Office (AMCO) who would like to make hemp products (CBD) or incorporate an endorsed hemp product into an already approved AMCO marijuana product ("approved form MJ-05 or operation plan changes submitted on MJ-15 or new products submitted on new form MJ-16").**

A compliant product combines ("adds, mixes, or incorporates") marijuana with a Division of Agriculture endorsed industrial hemp product, such as CBD isolate in its final form. A non-compliant product is one that combines a marijuana product with a hemp product that has been modified beyond the form that was endorsed for human consumption. For example, it violates state law to use CBD isolate endorsed by the Division of Agriculture, convert it to delta-8 THC, and further convert it to delta-9 THC before combining it into a marijuana product.
