Alaska Accepted and Prohibited Hemp Varieties

2026.03.05 Revision

***The Division of Agriculture does not guarantee THC Compliance for Alaska Hemp Program Approved Varieties**

Key Regulations:

- **11 AAC 40.210. Authorized seed and propagules:** The division will publish and update on an annual basis a list of accepted and prohibited varieties of industrial hemp seed or propagules.
- **11 AAC 40.215. Compliance with plant health and quarantine regulations:** Industrial hemp seed varieties that are offered for sale or acquisition in quantities of one pound or more must comply with the provisions of 11 AAC 34.
- **11 AAC 40.220. Seeds or propagules of wild, landrace, or unknown origin:** Registration holders whose operations included the use of potential landrace varieties of hemp, wild, or any other varieties or genetic lines of unknown heritage must contact the Division Hemp Program manager to arrange for replication and testing of the variety before it may be grown in Alaska.
- **11 AAC 40.225. Industrial Hemp propagules:** A registered grower importing industrial hemp propagules from outside the state and in compliance with 11 AAC 40.210 must ship the propagules to the division for inspection at the registered grower's expense.

Provided here is a list of all hemp varieties, strains or cultivars that have been approved for use in the Alaska hemp program. Because Alaska does not yet have extensive in-state variety testing data, the program relies on testing results and reports from other states to evaluate hemp genetics.

Some varieties are designated as **Prohibited Varieties**, meaning they have been proven to produce THC levels above the legal hemp limit of 0.3% and therefore cannot be grown or

acquired by registered growers in Alaska.

The list also includes **Varieties of Concern (VOC)**, which have had at least one test result exceeding 0.300% THC; while these varieties are still allowed, growers should use caution because they carry a higher risk of exceeding the legal THC limit and potentially having their crop ordered for destruction.

Additionally, certain cultivars are marked as **New Varieties**, which have been approved based on out-of-state certificates of analysis showing compliant THC levels but have not yet been grown or tested in Alaska, so their performance under Alaska conditions is unknown.

The varieties or strains listed in the table below without a **Designation** produced acceptable THC test results and therefore are not currently designated as a Prohibited Variety or Variety of Concern

Any hemp variety not included on the list **requires growers to contact the Division and obtain written approval** before purchasing seed or planting materials.

11 AAC 40.910 provides the following definitions:

(27) "hemp seed" means cannabis seed

(A) that is sold to or intended to be sold to registered growers for planting; or

(B) that remains in unprocessed or partially processed condition that is capable of germination;

(33) "landrace" means not systematically selected and marketed and not developed by plant breeders

37) "plant part" or "part" includes

(A) whole or partial unprocessed plants, including stalk, leaf, seed, floral, root materials, oils, resin, or wax;

(B) raw roots;

(C) fresh, unprocessed, dried, or ground leaves or floral material;

(D) rooted plants, cuttings, propagules, or clones; or

(E) any other portion of an industrial hemp plant;

(42) "Prohibited Variety" means a variety or strain of cannabis excluded from the Alaska Industrial Hemp Program

(44) "Propagule" means a plant or plant part that can be utilized to grow a new plant

(52) "seed" means an industrial hemp plant's unit of sexual reproduction intended to be planted for germination

(57) "variety" means a subdivision of a species that is

(A) uniform, in the sense that the variations in essential and distinctive characteristics are describable;

(B) stable, in the sense that the variety will remain unchanged in its essential and distinctive characteristics and its uniformity if reproduced or reconstituted as required by the different categories of varieties; and

(C) distinct, in the sense that the variety can be differentiated by one or more identifiable morphological, physiological, other characteristics from all other publicly known varieties, or other characteristics from all other publicly known varieties;

(58) "wild" means growing in the natural environment, not domesticated or cultivated.-
